

LOUDOUN COUNTY VIRGINIA RECORDS FOR CALEB GREENWOOD 1767 - 1772

Caleb & Rachel's marriage:

If the marriage was before 1757, it would not have been in Loudoun County. Loudoun County was created from Fairfax County in July 1757. Fairfax County marriage records do not begin until 1853 and there are relatively few marriage records for Loudoun County prior to the 1800s.

From the 1758-1781 Loudoun Co Tithable lists as abstracted by the Sparacios.

Note that males 16 years and older were taxed.

- 1767 * Greenwood, Caleb 1 tithable List for Colo. Nichs. Minors tiths; taken 1767 No. 2
- 1769 **Greenwood, Caleb** 1 tithable List of Tithables taken by William Douglass 1769
- 1770 **Greenwood, Kelap** 1 tithable; 5 squirrel scalps List taken by Wm. Douglass for 1770
- 1771 **Greenwood, Caleb**; **Greenwood, Baley** 2 tithables; 10 squirrel scalps List taken for Shelburn Parish by Josias Clapham 1771

The following two entries are from the Loudoun County Deed Books.

Note that a lease for lives meant that the person could lease the land as long as one of the three parties mentioned was living and they paid the yearly rent.

 Philip NOLAND of Ldn to farmer Caleb/Calip GREENWOOD (wife Rachel & son Baily GREENWOOD) of Ldn. Lease for lives of 100ac.
- 2) Deed Bk:Pg: G:166 Date: 11 Sep 1769 Returned to court: 11 Sep 1769 Philip NOLAND & wife Elizabeth of Ldn to Philip NOLAND Jr. Bargain and sale of 200ac where Thomas SHEILDS now lives, adj Caleb GREENWOOD, Josias CLAPHAM, Matthew RISLEY.

^{*} Note that there are two entries for 1767. It is possible that the commissioner wrote the wrong year on one of the entries.

The following are from Loudoun Co Order Books.

- 1) Order Book D, 10 April 1769
- [p. 168] Charles SHELL against **Caleb GREENWOOD** petition upon a note of hand petition is dismissed being agreed by the parties.
- 2) Order Book E, 8 April 1771
- [p. 93] Last will of Griffith MEYRICK deceased proved by witnesses **Caleb GREENWOOD** and William SMITH. Certificate granted named Executrix Hannah MEYRICK for obtaining a probate with Joshua JONES and William MELTON her securities and £500 bond. James SANDERS, **Philip NOLAND**, William WOOLARD and John TODHUNTER to appraise estate and Executrix do return the same to the Court.
- 3) Order Book E, 11 April 1771 [p. 111] [p. 111] William DEHAVEN against Henry EATON & **Calep GREENWOOD** petition upon a note of hand petition dismissed; Plaintiff to pay costs of Defendants.

Caleb Greenwood also was a member of a jury on a few lawsuits, the last which was recorded on page 350 in Order Book E, 23 Jun 1772

"The original land grants of Loudoun County cite Phillip Noland (Knowland) as having land in Broad Run which could be described as a "branch" off of the Potomac River. Loudoun Heights is closer to Harper's Ferry, and that land belonged to William Fairfax during the time period you cite.

I have searched for references to Greenwood and/or Bailey and have found none, other than the deeds you requested. I have searched all our birth, death, church, will, and chancery records and cannot find Caleb, Rachel, or Bailey. Neither Greenwood nor Bailey are present in the 1787 census.

I did find Baily Greenwood and Nancy Jarvis' marriage record in Marriage Bonds of Bedford County, Virginia 1755-1800 with John Jarvis listed as "surety". I could find only one other mention of John Jarvis. In 1790, he is listed as witness. This at least shows the Jarvis family was present in Bedford during the time period in question. "

Indenture made 8th April 1768 between PHILIP NOLAND Gent. of county

Loudoun of one part and CALEB GREENWOOD of said county Farmer ... 267-

Witnesseth in consideration of rents and covenants .. farm let parcel of land now in possession of said Greenwood beginning at a Sugar tree on Potomack River side mouth of a branch .. containing by estimation one hundred acres .. to have and hold during lives of Caleb Greenwood, RACHEL GREEN-WOOD his wife and life of BAILEY GREENWOOD his son paying every year the sum of Four pounds Ten shillings current money on first day January ..

At a court held 12th April 1767 .. Calip Greenwood Indenture acknowledged .. ordered to be recorded.
